In 2022, Dur-A-Flex completed the sale to Sherwin-Williams, after which Ferris led the successful integration of Dur-A-Flex into Sherwin-Williams' Global Supply Chain and Performance Coatings Groups.

Prior to Dur-A-Flex, Ferris was President of Charter Medical, Ltd., in Winston-Salem, NC, a business unit of Manchester, CT-based Lydall, Inc. At Charter, he successfully built the team that returned the company to profitability after an FDA product recall. Prior to joining Charter Medical, Ferris spent seven years with Princeton, NJ-based Tyco International, Ltd., where he served as Vice President of Strategic Marketing.
